


Section 3 - Renewable Energy


Question 1

Are you in favour of large numbers of solar panels **on the ground**, if the site is not easily visible from roads, footpaths or any public space?




Solar Panel Comments

Need to be situated away from houses & not dazzle.
Would need to be away from the villages.
I do not think they should be allowed on productive farmland.
(The government will never allow local use only).
Between Golberdon & Trevigro at the top of the hill. If not visible from residential / public areas
Lesser evil of power provision - necessary but ugly; less impact visually than turbines.
Solar panels site only for local community. One at Golberdon, Trevigro, South Hill; out of site, producing electricity for community.
It must not take hectares of green belt agricultural land.
These affect neighbouring properties. They are constantly humming.
I think these projects are important - but need to be thoughtfully placed so as not to upset one.
I can't think of anywhere, but if there was a place in the village that ticks all the boxes above.
On flat/valley land - not visible by local inhabitants.
An appraisal would need to be carried out to find South facing sites with suitable infrastructure.
Requires expert assessment & then consultation with owners and enablers.
Solar arrays are always visible from higher ground. It isn't easy to get farmers to allow hedgerows to grow up to obscure arrays. The array at Trefinnick Farm can clearly be seen as an eyesore from the B3257.
Agricultural buildings or trading estates.
If the community was to benefit + the landowner could be recompensed; but ultimately one wind turbine would be better. Anywhere not seen from the roads, footpaths + probably the neighbours?
Arable land should never be lost to PV. I feel strongly that they should be restricted to brownfield sites.
As stated, anywhere the site is not easily visible from roads, footpaths, public spaces.
Solar panels are a criminal waste of good agricultural land.


Wind Turbines need to be on a windy site. If you are in favour of them, can you suggest a site, or sites, that you think might be suitable.

Caradon Hill.

Treven, Golberdon Down.

Wherever is suitable. The only land that is wasted, is the footprint of the turbine.


Question 5

Please tick a box to show which of biofuel options that you are in favour of:




Question 6
