- 4. Matters arising from the Minutes of the Last Meeting:
- **a.** Cornwall Councillor Update. Cornwall Cllr Mc Williams reported that after some discussion the post of Chief Executive of Cornwall is being advertised and he/she should be chosen by September and be in place by November. The Planning Inspectors Report suggests that there needs to be more joined up thinking, regarding where homes are built and the availability of the right kind of work in those areas. At present there are far too many empty Industrial units. None of the parishes in Cllr Mc Williams patch have volunteered to join in the waste pilot scheme. There is also a need for recycling of mixed plastics, although the nearest plants are in Bristol or the North of England, not very environmentally friendly.
- **b.** Parish Web Site, new newsletter been published the committee would welcome feedback..
- c. Share, quotes are being obtained for purchase of and installation of solar panels on the Parish Hall roof. The Parish Hall Committee will pay half and SHARE will pay the other half.. The F.I.T. will then be shared. SHARE has a £1,000.00 per annum for the time being from the community benefit of the solar farm at Pitt, Proposed by Cllr Cornell and Cllr Clemerson. Cllr Hicks read a letter he has written to Callington Town Council, regarding the original agreement with the firm responsible for Haye Solar Farm, when monies were promised to properties within a given radius of the Farm. Cllr Skelton has applied to Callington Town Council for a proportion of the community benefit money received from the Haye Solar Farm
- **d.** Road remedial works and blocked drains, the white lines which gave the wrong priorities at Mornick will be reinstated correctly when the road is resurfaced.
